7CR payment structure

- Basic Pay Level: 7 Credit Remuneration System
- Rank Advancement Pay Level: Support Reward Bonus (SRB)
- Leadership Pay Level: Star Reward Program



7CR offers 3 different levels of earnings:

- The basic earning level, divided in 7, equally valued credits!
- The rank advancement earning level, called Support Reward Bonus!
- The leadership earning level, defined within the Star Reward Program!

7CR Remuneration Plan

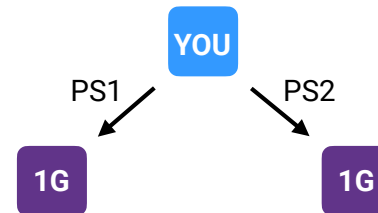


Our global 7 CR Reward Plan is based on a credit system, whereby 1 Full Credit represents 6.5% of the net retail price within each currency. Every product sale will be rewarded with a maximum of 7 Full Credits = $7 \times 6.5\% = 45.5\%$! A Full Credit consists of 1 Basic Credit (5%) and 1 Special Credit (1.5%), which will be paid out to you under certain conditions, which will be explained in detail later on!

7CR Remuneration Plan

Required Foundation:

Registration as a customer + 2 Personal Sales (PS)



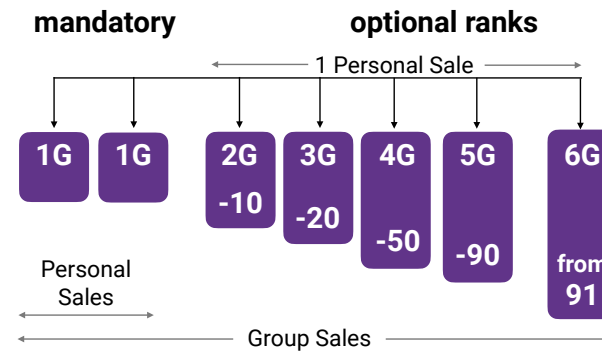
The more people you share the 7 CR Reward Plan with, the faster your team will grow and so will your income. Start with TWO personal sales in tow different legs to become fully eligible to all pathways and benefits of the 7CR remuneration plan!

7CR Remuneration Plan

1G	1+1 Personal Sales	6,5
2G	3-10 Group Sales + 1 Personal Sale	13
3G	11-20 Group Sales + 1 Personal Sale	19,5
4G	21-50 Group Sales + 1 Personal Sale	26
5G	51-90 Group Sales + 1 Personal Sale	32,5
6G	90 Group Sales + 1 Personal Sale	39

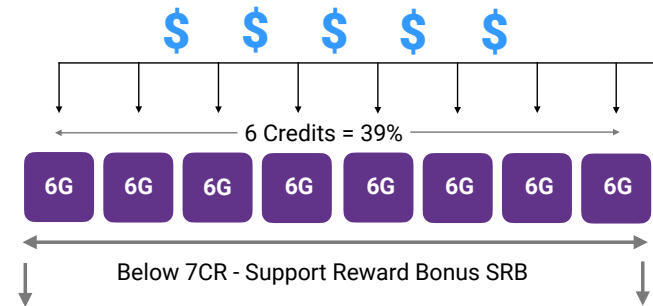
Once you registered yourself with us and you have made 2 personal sales, you reach the rank 2G. At 2G you receive 2 Full Credits (2 times 6.5% = 13%) for each future personal sale. After 10 cumulative sales by either you or your group, and an additional personal sale, you will reach the rank 3G and receive 3 Full Credits (3 times 6.5% = 19.5%) on each future personal sale. After 20 cumulative sales and one personal sale you reach 4G, after 50 cumulative sales + 1 personal sale you become a 5G, and after 90 cumulated sales + 1 personal sale you achieve the desired 6G rank. From now on, you will be rewarded with 6 Full Credits (6 times 6.5% = 39%) for each future personal sale.

Building to 6G



Ranks between 2G and 6G can be bypassed during monthly commission cycles by simply reaching the necessary qualification volume for each rank as stated in the slide above!

Building from 6G onwards



Once you reach 6G, you will be rewarded with 6 Full Credits (6 times 6.5% = 39%) for each future personal sale. In the same time, If you are already a 6G and your team has grown to the point, that there might be no credits left for you to be paid for new sales, you become eligible for the “Support Reward Bonus”.

7CR Remuneration Plan

Calculated from the bottom up!

The partner, who makes the personal sale gets paid first!!

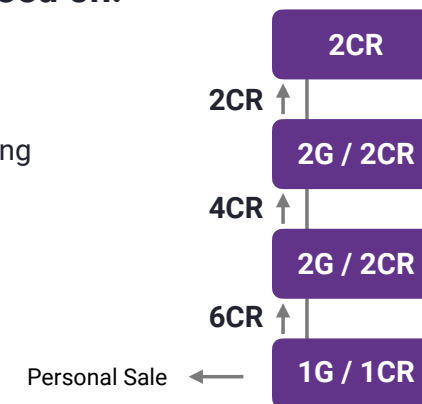


Credits are always calculated from the bottom-up, starting from the partner, who makes the personal sale.

7CR Remuneration Plan

The amount of credits you receive is based on:

- In which leg-position the sale happens!
- How many credits out of 7 are left when the counting reaches you!



For example: If a personal sale is made from a 1G rank, this person will receive 1 credit, 6 credits still move up. The 2G above will receive 2 credits, 4 credits still move up. The next 2G above again receives 2 credits, so the rest of 2 still available Credits out of 7 will move up to the upline, until no credits are left anymore!

7CR Remuneration Plan

Maximum Basic Payout (without bonuses)

\$ 45.5%

(includes Basic Credit BC + Special Credit SC)

Based on the 7 credit structure, valued with 6.5% each, the maximum payout percentage for every product sale without any bonuses is a guaranteed 45.5!!!

7CR Remuneration Plan

1 Full Credit (BC + SC) will always be paid to YOU in case of:

- Personal Sale
- Group Sale, if you create a Personal Sale within 90 days
(without a PS within 90 days, you will receive only the Basic Credit BC)!
- From the 181st day until the 360th day without a personal sale
you still receive 50% of the BC, afterwards 0%!

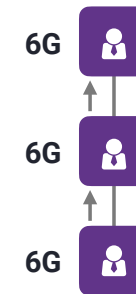


Full Credits are always paid out on personal or group sales as long as you make a personal sale every 90 days! If you do not meet the 90-day rule to benefit from group sale overrides, we will still pay you the Basic Credit of 5% instead of 6.5%... if you do not make a personal sale within 180 days we will still pay out 50% of the Basic Credit and only after 361 days without a personal sale we will no longer pay out commission to you.

7CR Remuneration Plan

6G Support Reward Bonus (SRB):

- Once you reached 6G, you qualify for the SRB as long as you maintain 1 Personal Sale within every 90 days = 100%, 180 days = 50%, afterwards 0%!!
- SRB pays on leg sales outside your 7CR range to the next 6G as following:
 - To 1. generation 6G: 4,5%
 - To 2. generation 6G: 1,25%



Once you achieve the 6G rank you qualify for the “Support Reward Bonus”. The countable volume starts below your 7 Credit lines –at those points, where no more credits are left to flow up to you – and reaches down to each of your 1st generation 6G. For those net sales volumes you will receive a reward of 4.5%. In addition you will receive a 1.25% reward for each sale under the 7 Credit lines of every 2nd generation 6G.

7CR Remuneration Plan

Cross country sales

The „7CR Remuneration Plan“ is valid in every country where SBS already has it's own subsidiary. Cross Country selling is basically possible. Please be aware of the following terms and restrictions:

The following countries are excluded from cross country selling: Saudi Arabia (KSA), La Reunion, Vietnam, Cambodia, Burma, China, India and the UK.

The list might be updated from time to time, please look out for updated documents in your personal back office!

Cross country wire transfers for earned commission can only be paid out, if the amount exceeds USD 100 / CAD 100 / CHF 100 / EUR 75 / HKD 800 / SGD 130 / GBP 80 - otherwise the administration cost exceeds the value of the commission. We also require all relevant account information for international bank wires from you. Third party fees (bank fees, check fees or other transaction fees) will be deducted from the commission before pay out. In addition and depending on the country, government rules require signed tax forms in order to regulate income tax reporting of the earned commissions. In case such a form is necessary, we will contact you, inform you and we are only legally allowed to pay out commission if the related and signed form will be provided from you in advance.

Our administration fee for compiling and allocating individual commission reports are as following: USD 7.50 / CAD 7.50 / CHF 7.50 / 5.00 EUR / GBP 5.75. The respective amount will be automatically deducted from your monthly commission report. We continue to provide and store all reports in your individual back office for your convenience.
